Online Judging Test!

The online judging test is now fully operational. If you have e-mail, you should receive a message one-month prior to your judging credential's expiration. It will have a link in it that takes you to the test. If you don't receive an e-mail, you can contact the office for the link.

Please note that there are some requirements to take the test:

- You must have been an active judge at least 3 years prior to taking the test.
- You must pass the test with a 90% score or better
- If you fail the test twice, you are required to take a seminar.
- New judges must take a seminar and ride braces to receive their credentials.

This should eliminate the need to extend credentials because someone couldn't make it to a seminar. If you have any questions, please feel free to contact me or the national office.

IMPORTANT THINGS TO REMEMBER!



Purina Endurance Classic:

Entry into this trial will be based on all open points earned from June 1 through May 31. Points earned from placements in the final "Top 4" of a National Championship trial or Regional Championship trial do not count; however, points from qualifying rounds do count.

TOP PERFORMANCE:

Dogs must have at least 20 open points from June 1 through May 31 of the applicable year to be eligible. Points will be from weekend trials only. From there, the award will be based on national trials and regional eliminations. The Performance Trial will be the beginning national trial each year, even if it ends prior to June 1 in order to keep the number of nationals the same each year. The Regional Elimination trial will be based on regularly scheduled regionals for each year and only one regional can count per year. Regionals scheduled or rescheduled to be held after June 1 will apply to the previous year. For national trials, a dog must make the Saturday cut to receive a qualifying score. Each national trial will have a point value of 800 points. The value will drop 25 points per placement throughout the Saturday cut (1 – 800, 2 – 775, 3 – 750, etc.). In addition, 100 bonus points will be awarded to the Champion, 75 for second place, 50 for third and 25 for fourth. Each regional elimination will have a point value of 600 points. The value will drop 25 points per placement until the last dog or points run out (1 – 600, 2 – 575, 3 – 550, etc.). In addition, 100 points will be awarded to the Champion, 75 for the second place dog, 50 for the third and 25 for fourth. The placement for the regional eliminations and national trials is determined by the score of the last round in which the dog ran.

HALL OF FAME NOMINATIONS:

Hall of Fame nominations will be accepted November 1 through March 31 of each year. Send these to the office. Nominations of dogs to the NSTRA Hall of Fame are NOT "carried over" to following years should the dog not be elected in the year nominated.

Plainly stated, a dog that does not get elected to the Hall of Fame in the year nominated must be re-submitted each year in order to be considered for election.

TRIAL SCHEDULES:

Fall trial schedules are due in the office by May 1. Spring trial schedules are due in the office by Nov. 1. All trials must be published on the website 4 weeks prior to their running.

SCHEDULING FEES:

Trial scheduling fees are requested in the NSTRA office at least 4 weeks prior to your trial date in order to mail the packets on a timely basis.

TRIAL REPORTS:

Trial reports are due in the NSTRA office 10 days after the trial date.

QUAIL INVITATIONAL:

This trial is always held the last week in February that includes a Saturday. The qualification period for this trial is Nov. 1 through Oct. 31. This includes all points earned during the time frame, except points earned from placements in the final "Top 4" of a National Championship trial or Regional Championship trial (qualifying rounds do count). Entry into the trial is based on points (dog with most points first to get in and on down the list, etc.). NO INVITATIONS WILL BE SENT. Any dog with a placement during the specified time frame will be eligible to enter. Amateur points do not qualify entry into Championship trials.

TRIAL OF CHAMPIONS:

The criteria for entry into this trial is that the dog has earned an open championship and is at least a 1X open champion by February 1 of the current year OR the dog can be a paid standby for this trial by achieving their open championship between February 2 and March 31 of the current year.

UKC PERFORMANCE CLASSIC:

The qualification for this trial is points earned from April 1 to March 31. Weekend trials only. No points from qualification or final rounds of national championship or regional championship trials will be counted.

DOG OF THE YEAR:

This trial will begin on Wednesday of the last full week of October. This trial is based on region elimination placement and/or high point status. All entries must be postmarked 45 days prior to the first day of the Dog of the Year trial. (NO INVITATIONS WILL BE SENT.)

HOME REGION:

Members requesting a change of Home Region must do so, in writing, through the National Office between the dates of October 1 and January 1. *Exception: A member who permanently relocates to within the boundaries of a Region, other than their Home Region, may make written application to the NSTRA office at anytime to request a change in their Home Region.

ASSOCIATE MEMBERSHIPS:

Associate memberships are available to members' spouses and children 18 years and under, still living at home. There must be at least one regular paid membership in the household to qualify. Associate members have the same rights as regular members EXCEPT they are unable to vote in any regional or national elections including rule or by-law changes, they cannot hold an office, and they do not receive a magazine.

RULE CHANGES:

Proposed new rule changes or additions shall be submitted sixty (60) days prior to the first day of the Trial of Champions and/or the Dog of the Year trial.

CONSTITUTION/BY-LAW CHANGES:

All proposed amendments to the Constitution and By-laws shall be submitted to the National Officers at least ninety (90) days prior to the first day of the Trial of Champions or the Dog of the Year trial.

IMPORTANT THINGS TO REMEMBER!

REGION HIGH POINT:

Points earned in the qualifying rounds of a Regional Elimination or a Championship trial DO count towards the region's high point competition. Points earned in the finals of above trials DO NOT count towards the region's high point.

OWNERSHIP CHANGE:

Once a dog takes a NSTRA placement, any subsequent ownership changes must be sent to the NSTRA office. Please send a copy of the papers with the new owners' names to the office. Transfer copies will not be accepted. The date of transfer will be the date shown on the papers.

FIRST TIME PLACEMENTS:

The National Office now requires a copy of the dog's registration certificate for first time placements. This can either be submitted by the owner or the trial chairman. We will accept copies by fax (317-839-4197), e-mail (office@nstra.org) or a photocopy by regular mail.

NSTRA Distinguished Members:

The NSTRA Distinguished Members award honors those extraordinary men and women whose contributions and achievements significantly helped develop, or continued to improve, the National Shoot to Retrieve Field Trial Association, Inc. This award will be presented annually at the Dog of the Year banquet. Nominations are to be submitted by August 31. A short description of the individual and their contributions to NSTRA should be sent to the national office. A picture of the individual should be included if available. Contact the NSTRA office for a list of criteria.

The committee will review all nominations and verify contributions. Decisions will be made not only by the information submitted but by any other information collected.

The committee will make their decision by September 30. A permanent plaque will be located at the NSTRA office with a smaller plaque awarded to the individual or their family if deceased.

OUR NSTRA LEGACY

I'm Nick Hachman and I started bird hunting when I was 24 years old. I was interested in hunting before then, but the opportunities for me to hunt were not abundant at the time. When I had the chance to join some extended family on a trip to South Dakota for opening weekend I seized it. The birds were plentiful, and we had a successful hunt, but there were many other things to enjoy than simply harvesting birds. My fondest memories of those early years are of building relationships, sharing stories, seeing the countryside and not least of all, watching bird dogs perform the job they were bred to do. Bird season lasts about 10 weeks here in the Midwest. Work and the holidays can make a bird season fly by before you know it. If you are blessed with the ability to travel, there are more opportunities around the country to extend the season. Another option for spending more time with bird dogs and the people who love them is to participate in a sport such as NSTRA.

I was introduced to NSTRA by one of the same family members that took me on that first bird hunting trip to South Dakota a few years prior. We had hunted over his old Brittany and when he had a litter of puppies in 2009, I was given pick of the litter for my very first bird dog. Once I had my pup, we started talking about this field trial thing. It sounded fun, but at the same time, very intimidating for a person new to bird dogs. Would my dog be good enough to compete? Could I train her to the level required? Was I going to be a good enough handler? Had I not had that family member who had some experience, I may not have ever had the confidence to get into the sport. We learned together, mostly through failure. Even though we were not winning, we were still enjoying every minute of it. Spending time outdoors training dogs, watching other dogs at the trials, talking with other trial participants and spectators and the 30-minute braces where we would try to put together a good run with our dogs. Eventually, we did become competitors and began placing in trials here and there. My family member is not currently active in the sport, but I have continued. That first dog of mine is now a 2x NSTRA champion and has finished in the top 8 at a national trial. I had another dog finish runner up at the 2018 Mo-Kan Regional. You could say that I have been hooked.

This sport is in my blood now and I hope to be involved for the rest of my lifetime. I also want to share what I have found with as many other people as I can. I want to help ensure the survival of the sport so that it continues through my lifetime and beyond. The NSTRA officers and membership are also committed to this mission. Many new programs, trial formats, rule changes, incentives, etc. have been front and center the past

few years. We should be thrilled about the progress that has been made and I feel like the barrier to entry has been lowered while at the same time preserving the prestige of the Open format and championships. Our next step is to use these changes to attract new members to the sport. Our elected officers and other volunteers have done the work to enable us, the members, to use these new tools to grow the membership.

Over the last 10 years I have had many NSTRA members step up and help me learn and improve both myself and my dogs. Without their help and encouragement, I may not have persisted. I believe that this is the key to both our sport's longevity and growth. Experienced members need to invest in those new to

the sport, or not yet participating. Mentoring handlers, giving dog training tips, explaining the intricacies of a field trial and the rules and etiquette. These things cost very little except your time. Offer to get together for training sessions if you have access to land, birds and equipment. This can be a very valuable thing for a person who is getting started and may have limited or no access to these things.

How do most people become aware of NSTRA? I think we can agree that the primary way is by word of mouth. Most of us have hunting buddies, family, co-workers or friends that have dogs and would be interested in NSTRA. Some of us are involved in dog breeding, guiding hunts, professional training and other

outdoor activities where we encounter potential new participants for NSTRA. Building awareness of our sport is going to be paramount in a world with so many other choices for things to spend your time on. Talk to people, let them know how easy it can be to get started in the sport. Tell them the enjoyment you get out of the sport and the people involved. Educate yourself on the new amateur program so that you can highlight the benefits to new members. Invite interested people to spectate a nearby trial, arrange to have them ride with a judge and introduce them to other members.

As members, we cannot sit back and rely on the new programs, trial formats, rule changes and incentives put in place to add new members by themselves. These are the tools our officers have given us to go after new members. I am writing this as a challenge to current members to utilize these tools and take an active role in membership growth. Give back to the organization and its members that have been providing you with the enjoyment of our dogs, the outdoors, competition and friendship. ■

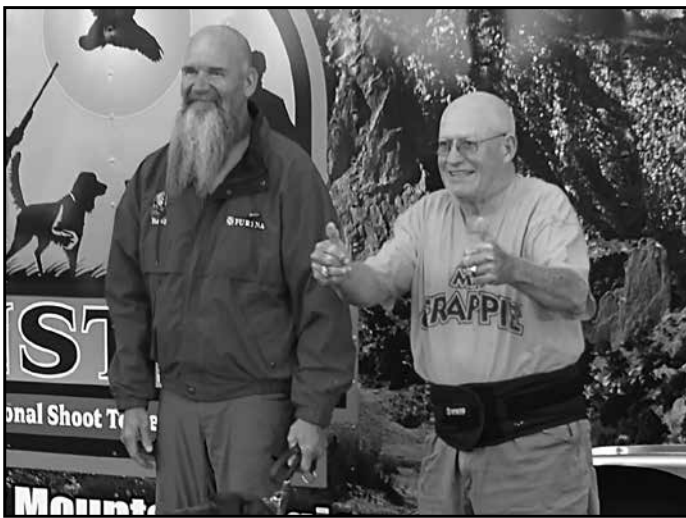

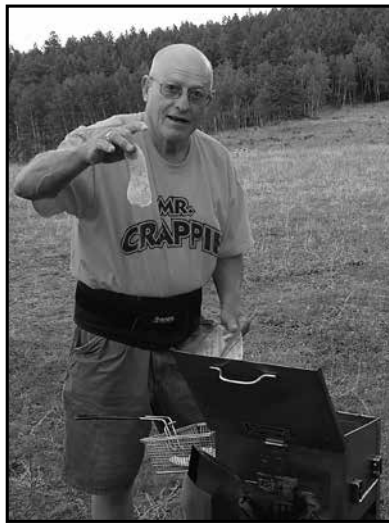

From the NSTRA office:

HOW DO WE SPEED UP THE PRODUCTION OF THE NSTRA MAGAZINE SO IT IS NOT DELAYED?

THERE ARE EASY SOLUTIONS:

Let's discuss how we can efficient get information to the office for publication into the magazine. We are getting better all the time now that we have extra staff members, however, sometimes we can get behind in the office. Also we have vacations, holidays, illness, other office deadlines and national trials that sometimes take priority. We have added in extra lead time for submitting articles so regions/members have time to collect information before submitting to the office.

Most often the magazine can be delayed; because we are emailing, calling or chasing down information that should have been submitted with the article and/or photos, waiting on pictures to be submitted or resubmitted in the correct format and size. Often times photos are submitted with an article, with no captions to identify the members, this results in having to email or make calls to request information, which then we have to wait for further information to be sent back to us.

As we get to the spring season and get involved with regional eliminations and back-to-back national trials, we become extremely busy in the office. This will make it harder to devote additional time to collect the missing information from a region or member. Having to call for missing items and photos considerably delays the magazine.

HERE IS HOW TO HELP STREAMLINE THE MAGAZINE:

Make sure you meet the deadline.

The deadline for all magazines is ALWAYS the first of the month, prior to the publication date. The "deadline" is when ALL info from regions are to have their items into the office, no later.

It takes about a week for the office to assemble all articles, trials, photos that are being published in the magazine. We usually have to allow for late trial articles and alterations, however this should only be minimum items, however lately it appears to be many items. The office and the designer work together to get all information correctly in the magazine. Once it is approved, our deadline to the printer is tentively the 20th of the month. We have to add in time for printing, as well as mailing. Our goal is to have all this streamlined and the magazine is on-time!

Below is the deadline and final date for all items being submitted for the magazine:

SENDING PICTURES:

Rule 1: Cell phones don't produce quality newspaper photos.

It may look nice on your cell or computer screen, but cell phone photos rarely contain enough contrast and detail to produce anything decent on newsprint. If you must send us a cell phone photo, please submit the photo in the largest format it is offered. Otherwise we will not be able to use your photo.

Rule 2: Give us one good photo, and there's a good chance it will be printed. Give us 20 lousy photos, and there's a good chance none will be.

Even experienced photographers with good cameras can take some pretty lousy photos. Images can be too dark or too light, sometimes we can fix that. But we cannot fix an out of focus photo. Perhaps take a few of each subject to make sure you get a good one.

Rule 3: You shoot it, you name it.

Please include identification for each individual in the photo. Please ensure that names are spelled correctly. After taking a photo make sure to ask those in the photo for their full name, dog name and any titles. If you are using your cell phone to take photos, use the notes in your photo to type out all the names so you have info when you are ready to submit to the office.

If the photo is numbered Image223.jpg then number your caption the same: Example: Image223.jpg Jane Doe with Lucky. The office no longer has time to pull trial results to figure out who is in your photos.

Rule 4: We're trained in surgery; let us cut.

Please do not submit cropped, flopped or "Photoshopped" images. Just send good, high res photos and we will take care of the rest.

Rule 5: Do not embed your photos in to a word doc or save photos as pdfs, always save as a .jpg separately from your article.

BEFORE YOU SUBMIT YOUR ARTICLE:

Rule 1: Proofread your article

Most of us aren't English majors but please try to have someone else look over your article before you send it. Capitalization, punctuation, sentence structure, etc., Are all things that take time for us to edit.

Rule 2: Name Your article

Often articles come in separate emails, name your article in the "subject line" of your email as well as the "file" that you send. Do not name your article, "Here is an article for the magazine" ... Perhaps use your Region, or Article headline. If photos are sent separate from your article, please name those emails the same name. This way we can match up the articles with the correct photos on our computers.

Rule 3: Format correctly.

Some of the items that you are to submit have specific formats that we have requested. Your region trial schedule is the largest one. Please make sure you have it formatted correctly. It makes it super easy to drop in the magazine and online if it is submitted correctly.

*If all these things are followed, the magazine would not be delayed.
We appreciate your prompt attention to this matter!*

It sure doesn't hurt to win a National or two either.

I was there with a string of young dogs that I was looking at, trying to find a replacement for my Micro Chip dog that was forced into retirement at the age of 5 due to an injury. As I sat in my truck, I watched John Gillespie run a brace with a real young pointer for its first time. If I remember correctly, Jimmy went birdless! LOL!. Not uncommon for a beginner, but what caught my attention was how nice he ran. It was huge, from one end of the field to other, several times. I was laughing to myself thinking I have had braces like that. Jimmy actually had a couple unproductive finds, so I was able to see him on point and he looked great.

As John was coming off the field, I commented to him about his brace and mentioned how nice Jimmy looked and that he was a good-looking prospect. At this time Jimmy was around 10 months old.

The trial ended and I went back to Michigan. I believe it was about a month later the phone rang and it was John Gillespie. We chatted for a minute and if anyone knows John, he loves to buy, sell and trade, and he is outstanding at it! John asked me if I would be interested in buying Jimmy. We talked for a few and I told him I was interested and asked him if he would he give me some time to think about it. John agreed and said he was heading to Kansas to go hunting and had Jimmy with him, think it over and let him know. The Regional elimination trial is always the pinnacle of the trial season. This year was no exception as all the dogs that had placed during the season along with previous champion dogs flocked to Newton Utah to battle it out for the Utah region crown. Judges Jerry Youmans and Michael Ouchida had come all the way from the Northwest region to judge the trial. They found the trial grounds in a brilliant shade of green from this springs wet weather. Old friends and newer friends gathered around the club tent to wish each other luck as the first braces were underway.

In the Elimination round, last Year’s Region Champion 3XNSTRA CH Sunnie and Handler Bret Wonnacott had a 4-4 run to score 751 to win. Dan Felter and Moose had the second-best run going 3-3 for 678.5. Bret Wonnacott and the ever-present, 3XNSTRA CH Tic finished third with a score of 655. TIPS FOR MAPPING DOG-FRIENDLY PIT STOPS ON YOUR NEXT ROAD TRIP



Hitting the road is all about preparation, especially when your bird dog's in tow. Traveling with your canine athlete requires extra effort on your part to ensure his or her safety and comfort, whether it's packing the gear and essentials needed for a field trial or hunting trip — such as food, water, tie-out cables/stakes, first-aid kit and veterinarian records, just to name a few — to doing your homework and plotting adequate travel breaks along your route. Regardless where your next road trip takes you, these tips can help you plan for those tried-and-true dog-friendly pit stops on the journey ahead.

TRAVEL ESSENTIALS TO PACK FOR YOUR BIRD DOG

If your dog's travel schedule will differ from his or her day-to-day, practice that routine prior to leaving home.

OFF THE BEATEN PATH

Interstate rest areas, fast food drive-thrus and gas stations are among the obvious pit stops for humans, but likely not the safest choice for your bird dog. Heavy traffic, garbage, fuel spills and other motor vehicle fluid leaks pose a dangerous threat to your dog. Instead, seek out nearby commuter parking lots, text stops or parks that have grassy space to give your dog ample room to stretch his or her legs. Don't forget to pack waste bags and always clean up after your dog.

A 'CHAIN' WOULD DO YOU GOOD

Dog-friendly chain stores, such as pet, agriculture, outdoor and home improvement retailers, may offer options to air your dog in a reserved area or to bring him or her inside the store. Be aware, though, that local ordinances may supersede some stores' policies, with the exception of service animals. Call ahead to an individual store and location to verify before stopping in with your bird dog.

THERE'S AN APP FOR THAT

Sure, you've done your homework and mapped out every stop to a T, but don't forget Murphy's law. Should your dog need a break before the next planned stop or an urgent situation arise, look to your smartphone. Useful apps include BringFido to help you seek out dog-friendly pit stops, VetFinder24 to readily locate emergency veterinary services, CamScanner to store and recall your dog's important veterinary records, and Pet First Aid to provide first-aid instruction in a pinch.



DOG TIRED

Contrary to popular belief, travel isn't restful for a dog, zapping his or her energy both physically and mentally. After a long day on the road, a good night's sleep is in order. If your dog will sleep in a dog box in your truck (don't forget soft, comfortable bedding!), park in an area free of distractions to minimize stress and maximize rest. Or if your hunting partner will sleep alongside you, check ahead of time to learn which hotel chains, Airbnb listings or campgrounds are dog-friendly.
